

THE ACADEMY'S CHARTER WAS NOT RENEWED AND THE SCHOOL CEASED OPERATIONS AT THE END OF THE 2018-2019 SCHOOL YEAR. THIS DECISION HAS BEEN APPEALED; ON FEBRUARY 2021 THE MSDE UPHELD THE DECISION NOT TO RENEW THE SCHOOL'S CHARTER. OPERATIONS FOR THE YEAR ENDED JUNE 30, 2022 REFLECT THE REVENUES FROM RENTING A PORTION OF THE BUILDING OFFSET BY THE COSTS OF MAINTAINING THE BUILDING.
